2. Scope and Acceptance of Terms. Contract Formation.

These terms (the "**Product Terms**") set forth the terms governing the rights, obligations, and liabilities relating to Beckham Law Guide service ("**The Product**") as contracted on or through www.LexBeckham.com (the "**Site**").

These Product Terms apply only to the Product and do not apply to any other products or services offered or available on the Site.

By purchasing or accessing the Product, you acknowledge that you have read, understood, and agree to be bound by these Terms.

The electronic contract is formed when the Client completes the purchase process, accepts these Terms and receives confirmation of the transaction.

3. Product Description

The Product provides time-limited access to digital content which consists of a series of pre-recorded educational videos delivered via streaming access, relating to Spain's Beckham Law of Spain (special tax regime provided for in Article 93 of Law 35/2006, of 28 November, on Personal Income Tax).

The content is provided strictly for general information and educational purposes.

Access duration, renewal terms, and available content depend on the subscription plan selected at purchase.

4. Intellectual Property

All content included in the Product, including but not limited to videos, materials, and underlying know-how, is owned exclusively by LexBeckham or licensed to it.

Raúl González Weber, attorney admitted to the Madrid Bar Association (ICAM) under membership number 137.787 ("**the Author**"), is the intellectual author and narrator of the videos included in the Product.

LexBeckham has contributed to the videos with technical production, post-production, editing, hosting, platform infrastructure, and related expertise necessary for the creation and delivery of the videos but does not have intellectual authorship or creative control over the substantive content.

The work is protected under Spanish Intellectual Property Law, and LexBeckham is the exclusive holder of its exploitation rights. Any unauthorized use may result in legal action.

5. Pricing and Payment

The price is the amount displayed on the Site at the time the Product is purchased, including applicable taxes and, where applicable, the billing frequency.

Prices, access durations, and included videos may vary depending on the subscription period. LexBeckham reserves the right to modify pricing, subscription models, and content offerings at any time, provided that such changes will not affect already confirmed and paid subscriptions.

Payments, billing cycles, and refunds are governed by the Site's Payment Terms, which are incorporated herein by reference.

6. Client Responsibilities

The Client:

- Must use the content exclusively for lawful, private, non-commercial purposes.
- Shall not record, download, reproduce, distribute, modify, or publicly share the videos in any manner.
- Shall not attempt to circumvent any technical protection measures;
- Shall not misuse, reverse engineer, or exploit the Product.

LexBeckham reserves the right to immediately suspend or terminate access to the Product without any compensation if the Client breaches any of the obligations under this section.

7. Provider Responsibilities. No Professional Advice Disclaimer.

The Client acknowledges and agrees that:

9. Force majeure

Any delays, suspensions, or failure in providing access to the Product due to events beyond the Provider's control shall not give rise to any liability for LexBeckham (e.g., natural disasters, government shutdowns, internet outages, or platform failures).

10. Governing Law

These Terms shall be governed by and construed in accordance with the laws of Spain, without regard to conflict of law principles.

11. Dispute Resolution

Any dispute arising out of or relating to these Terms shall be submitted to the exclusive jurisdiction of the courts of Madrid, Spain.

12. Severability

If any provision of these Terms is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

13. Entire Agreement

These Terms, together with the Payment Terms and the Site's Terms of Service, constitute the entire agreement between you and LexBeckham regarding the Product.
